## INFORMATIVE EX ART 13 D.LGS. 196/2003 - Code concerning the processing of personal data AND OF THE REGULATION U.E. (RGPD) No. 679/2016

Dear Madam / Sir,

We inform you that your personal data will be processed, with your consent, with or without the aid of electronic or automated systems.

The provision of data is optional; however, a refusal makes it impossible to send information on the institutional activities of the Pro Musica and Arte Sacra Foundation.

The Data Controller (T.D.P.) and the Person in charge of personal data (R.D.P.) is the Fondazione Pro Musica and Arte Sacra with registered office in via Paolo VI n. 29 (Piazza San Pietro) - 00193 Rome, to which you can contact for the processing of your data.

The provision of data allows the processing of personal data. The legal basis that justifies the processing of the data provided is the declaration of intention to carry out "a donation" (contribution to institutional activity) and the fulfillment of legal obligations. The data collected, provided by those who have expressed the desire to do a contribution intended for institutional activities, will be treated exclusively:

- to receive information on the institutional activities of the Foundation by sending letters, invitations, newsletters / releases by usage of electronic mail, not encrypted by the processor, and by regular mail and in any case to receive free information on the institutional activities carried out by the Fondazione Pro Musica e Arte Sacra, including those relating to the promotion of the Foundation's institutional activity.
- for the fulfillment of the obligations required by law.
- to be able to record at events organized by the Pro Musica and Arte Sacra Foundation.

At any time you can obtain the cancellation in part or in total and get anonymity, updating or correction of your personal data, and exercise the other rights provided by the combined provisions of art. 13 and ss. of Legislative Decree 196/2003 and of the U.E. Regulation (RGPD) n. 679/2016, writing to [privacy@promusicaeartesacra.it](mailto:privacy@promusicaeartesacra.it).

### Rights of the interested party: information, correction, cancellation and blocking, right of opposition

In accordance with § 15 RGPD, the interested party has the right, at any time, to request complete information on their personal data submitted and stored to the Data Controller and request and obtain information on the archiving process.

According to § 17 RGPD, the data subject may at any time request **the rectification, deletion and blocking** of personal data to the Data Controller.

Furthermore, the data subject may exercise his **right to object** at any time without stating the reasons and modify or revoke the declaration of consent provided with effect for the future.
